

Differences of opinion. We all have them and they are, in fact, a healthy sign of a diverse and vibrant community. Community differences of opinion can lead to better solutions—if we don't allow them to divide us.

The uncertainty of the pandemic has created divisiveness, particularly regarding the wearing of masks. As elected officials, we've experienced strong disagreement on the necessity and effectiveness of a citywide mask ordinance: the Provo City Council is supportive while Mayor Michelle Kaufusi is opposed. But to be clear, we were never at odds in our desire to see compliance with health guidelines from state and county health experts, including guidance to wear masks.

On August 26, Mayor Kaufusi vetoed a citywide mask mandate unanimously passed by the Provo City Council. The Council subsequently overrode Mayor Kaufusi's veto with a 6-1 vote, enacting a citywide law now in effect. Citing enforcement as a primary concern, Mayor Kaufusi believes voluntary compliance achieved with education and encouragement is best. The Council fully supports education but felt the formality of an ordinance with its signage requirements would be most effective.

Whatever the outcome of our debate, some citizens would feel disappointed, but the checks and balances of government worked as intended. Like every community, Provo City has had, and will continue to have, its share of opposing viewpoints on a variety of issues. Despite our difference of opinion, our goal now is to find common ground and move forward to keep our community and its economy healthy. This is not only a goal we share as your elected officials, but one for which we need community support to be successful.

Provo City has a history of coming together as a community when it matters—now is one of those times. Join us in:

Help Protect Area Homeless from COVID-19 Donate to the Utah County Housing First Fund


The local homeless and at-risk-of-becoming homeless populations continue to be the most vulnerable groups during the ongoing pandemic. Area service providers need your help to "protect, keep alive, and house" these at-risk individuals in our community. You can make a difference during the pandemic by donating to the Mountainland Continuum of Care Utah County Housing First Fund.

TRULY HELPING LOCALLY

- 100% of Utah County Housing First Fund donations go towards removing barriers to permanent housing for local homeless individuals and families or to prevent people from becoming homeless.
- All requests are made by service provider staff and no funding is ever given to the client directly.
- Since the fund was created in October of 2015, over 96 local residents have been served by these generous dollars.

The Mountainland Continuum of Care is a coalition of agencies in Utah, Wasatch, and Summit counties committed to ending homelessness in our community. As a continuum, they coordinate our efforts and pool their resources to better serve our communities by helping individuals along the housing continuum, from emergency shelter to homeownership.

WE'RE SORRY. New Billing System Transition Causes Difficulties

Provo City Customer Service (311) is aware of recent citizen billing concerns as a result of a new software conversion that created some expected transition challenges we are working to resolve. Please accept our apologies for any confusion caused or inconveniences experienced as we've implemented the new system. We are excited that with this new system we will be able to serve you better and more efficiently than ever before. Should you have any questions or concerns regarding utility billing or service, please reach out to the Customer Service Department by dialing 3-1-1 (inside Provo City limits) or 801-852-6000.

WHO DOES WHAT?

- · Provo City's Customer Service Department (311) handles billing for all utilities in Provo including water, wastewater, storm water, solid waste, and power. All utility billing issues should be directed to 311 Customer Service by dialing 3-1-1 within Provo City limits or by calling or call 801-852-6000.
- · Provo Power handles the engineering, infrastructure, and labor for services related to electricity within the Provo boundaries. Questions regarding rate structure, power reliability and service, and the planning or engineering of our electrical grid should be directed to Provo Power at (801) 852-6852.
- · Provo Public Works manages the following; water, sewer, and storm drain infrastructure, residential garbage, green waste, and recycling pickup, the Provo Airport, maintenance of streets, curb, gutter, and sidewalk, snow removal, and traffic signals. Questions regarding these services can be directed as follows: Water, Sewer, Storm Drain, and Sanitation rate structures - 801-852-6726, Water or Sewer service - 801-852-6780, Storm Drain or Sanitation service - 801-852-6700, Infrastructure construction permits and utility inspections - 801-852-6740.

WHAT DOES IT DO?

ALL INDIVIDUALS IN PROVO CITY TO WEAR FACE COVERINGS WHEN:



In indoor public spaces when not social distancing



in indoor public spaces when more than 50 are in attendance

in outdoor gatherings where more than 25 are in attendance and not social distancing

- All businesses must post signage of the face covering and social distancing requirements.
- The ordinance requires organizers of public gatherings to require attendees to wear face coverings and to provide clear signage of the face covering and social distancing requirements
